## NYSUT RA REPORT: CHANGING NEW YORK

March 16-18, 1995

It was a quiet convention. A pall was cast over the proceedings by the pervasive realization that the world as we have known it is being turned upside down. The weather in Rochester was a preview to spring, pleasant and inviting- but the political climate throughout the state and nation is as gloomy and frigid as last year's snow.

Speaker after speaker cataloged the many educational programs and services that will disappear if the proposed cuts in spending are adopted. For three days, the delegates heard predictions of gloom and doom, but always the final message was that we must stand tall together in order to weather the storm.

Ray Skuse, Director of the NYSUT Legislation Department, announced that there will be a supplementation bill for all retirees throughout the state, or there will be " an all scale war." He also said that legislation has been introduced to extend the moratorium on

retiree health insurance changes for another year. He vehemently stated, "I am 75 years old, and I have never seen it as bad as this." He charged that the Pataki agenda is being controlled by "Change New York," a group of wealthy businessmen whose ideology is focused on having all State services and programs taken out of the public sector and put in the hands of private corporations and businesses.

The projected tax cuts Pataki has proposed to give back to the corporations will raise the deficit, and this will be made up on the backs of the public school system, including drastic cuts in SUNY and CUNY, elimination of teacher centers, mentor programs, EIT money, and aid to schools, among other cuts.

This will put the future of our children in the hands of the privileged through vouchers and privatization. We must get involved!

## HOW DID WE DO? (ACTIONS ON OUR RESOLUTIONS)

#### **ADOPTED**

### SAFEGUARDING PENSION FUNDS

RESOLVED, that NYSUT continue its efforts to safeguard public employee pension funds for the exclusive use of pension payments.

## ELIMINATE THE TIER SYSTEM

RESOLVED, that NYSUT make one of its major goals legislation to achieve equalization of benefits; and be it further

RESOLVED, that this legislation be aimed at equalizing all benefits at the highest level without regard to date of membership.

#### PENSION SUPPLEMENTATION

RESOLVED. That NYSUT continue as one its top priorities to work diligently for pension supplementation for all New York State public sector retirees.

## PERMANENT COLA

RESOLVED, that NYSUT continue as one of its top priorities to seek legislation to establish a permanent COLA to all New York State public sector retirees.

# RETIREE COUNCIL RESOLUTIONS TO AFT CONVENTION

RESOLVED, that NYSUT seek changes in the AFT Constitution to grant to all chartered AFT retiree councils the right to submit resolutions to the AFT Convention.

#### COBRA COVERAGE

RESOLVED, that NYSUT seek and support legislation which will extend retirees' COBRA rights.

### NATIONAL HEALTH CARE

RESOLVED, that a mandatory system of universal health care be established.

## REFERRED TO THE BOARD OF DIRECTORS

## HEALTH INSURANCE PRO-TECTION FOR RETIREES

RESOLVED, that NYSUT continue to promote and support legislation that would guarantee health insurance coverage for retirees that is at least the equivalent to that provided active employees in their respective school districts, but not less than the level of coverage enjoyed by said retirees at the time of their retirement; and be it further

RESOLVED, that such legislation continue to be given the high priority assigned it by past Representative Assemblies of NYSUT.

## HEALTH INSURANCE MORATORIUM

RESOLVED, that NYSUT pursue legislation to maintain the moratorium that was established during the 1993-94 legislative ses-

sion that dealt with the maintenance of retiree health insurance.

## NONCONCURRENCE

#### NYSUT STAFF ASSISTANCE

RESOLVED, that the NYSUT Board of Directors consider increasing significantly, the current staffing accorded the retiree office of NYSUT headquarters.

## PROVIDING STAFF ASSISTANCE TO RETIREES

RESOLVED, that the NYSUT Board of Directors consider designating a staff member in each regional office to serve the needs of retiree councils and retiree chapters.

#### ELECTION OF RETIREE TO NYSUT BOARD

RESOLVED, that the NYSUT Board of Directors consider a constitutional amendment to provide for the election by the retiree delegates of a retire member of the NYSUT Board of Directors, with full voting rights and privileges.



## LEGISLATIVE REPORT

Jack Zuckerman, Retiree Council 21

(This was written after a public hearing held by members of the State Assembly Standing Committee for the Aging held at SUNY Farmingdale on March 10,1995 to

ascertain the impact of the governor's budget recommendations).

This is not a good time to be concerned with political/legislative issues in New York State and the United States. It is with great sadness that many of us see the progress made in the 20th century being dismantled at such an alarming rate. Once again we see those who were elected to represent all the people driving with such dedication to lower the quality of life of those who can least protect themselves. It is

a good time to have influence, power and money in our nation.

Certain assumptions have been made by those supporting the "Contract on America." One is that the budget must be balanced. This assumes that government must be run as a Ma and Pa store, or even as an ordinary family. No one in the modern world can live by a legally balanced budget. Could WW II have been fought and won with a balanced budget? Could you imagine Congress financing the war with a 2/3 or 3/4 vote? Do you know a family that is able to avoid debt and still possess a car and a house? Yet there are those who wish to put us on a pay as you go basis. This alone could destroy the Middle Class, if not those who haven't reached this

status yet.

Scare words are being shouted at us day and night by those who should know better. WELFARE CHEATS is an example. Let's put all the people on welfare to work. In our area, if not all over, a majority of recipients are mothers with dependent children. Who will be punished if the mothers are forced to go out to work? Will there be more money for day care centers? GOVERNMENT BUREAUCRACY is another example of scare words. Would the TVA have been built without the US government? Power companies would not go into an area in which they could make no money. But now that the TVA is viable, these same companies want to privatize the operations. ELITIST PUBLIC BROADCASTING is another catchy phrase. This assumes that programs that deal with drama, the dance, and classical music are beyond the level of ordinary people like ourselves. Of course, if public broadcasting would allow the right wing fossils of our country the right to dictate the content and political orientation of programming, how much objection would there be?

A few years ago, Kentucky Fried Chicken, now mercifully defunct, tried to lobby its way into privatizing education. We can run the schools on a business basis and save everyone money, they said. If children could be processed like fried chicken, there

could be merit in the idea.

WE ARE GOING TO GIVE THE MIDDLE CLASS A TAX BREAK. Yes, we would all like a tax break. But where will the money come from to pick up the garbage, maintain hospitals, run schools, maintain life guards at the public pools and beaches? From two places, my friends. If municipalities receive less money, guess what will happen to our property taxes? And we have yet to hear any of our financial gurus deny that the budget would be balanced by raiding our Social Security Trust Funds and placing our hard won checks in jeopardy.

It is time to launch our drive to remove the rascals from office. The NRA, the AMA, the Pro and Anti Choice groups, the Pro and Anti Environmentalists, have all boasted bumper stickers which read: "We Vote." Now it is our turn. "We Vote and We

Taught You How."

It is time to remember that this is one nation which promised its citizens liberty and justice for all. Nowhere does it say that it applies only to those who can afford it.

## MEMBERSHIP

ROBS was formed to be an inclusive. not an exclusive, organization. We call "Retirees of Brentwood ourselves Schools" because it is our intention to join together teachers, secretaries, and clericals, in one unified group as retirees.

The ROBS Constitution and By-Laws define our intent clearly! Membership shall be open to retired Brentwood employees who are eligible for membership in NYSUT. (The only body which may legally determine eligibility is the Brentwood Teachers

Association).

A category of Membership has been created for those who were retired prior to the Secretaries/Clericals affiliation with BTA. (Through this category, all retired secretaries and clericals are eligible to become members of ROBS. and to participate in social, cultural, and educational activities. Membership in this category may not include participation in any NYSUT activity, such as voting for officers).

3. A category of Membership has been created for those secretaries whose work was defined as "Confidential Secretary." (By the nature of their work, these individuals were not permitted to belong to any bargaining unit, and were therefore automatically excluded from NYSUT membership. Membership in this category may not include participation in any NYSUT activity, such as voting for officers).



## CAMEO

This is a Cameo written with love by me for a former teacher of mine who is not a Member of ROBS. But this person affected the working lives of all of us by his work

in making the climate for teachers' unions fertile for the birth of NYSUT.

CHARLES COGEN came to Bay Ridge High School in Brooklyn as Chairperson of the History Department in 1951, the year I was a senior. Since I had been instrumental in reorganizing the Book Room, I always said kiddingly that "I taught him everything he knew." Which, of course, wasn't true at all. He actually taught me so much more: about involvement during the teacher strike that year when he was head of the newly forming UFT. Some of us students got out there on the line with the teachers.

Over the years, we kept in touch. He and I went different, and yet parallel, ways of activism. His presidency of the UFT took him into controversy at the AFL-CIO

convention in the '60's. And I was so proud of him.

After his retirement from teaching and the UFT presidency, he and his wife, Tess, lived in Manhattan, where he remained active at the Union offices there. In 1992, after the death of his wife, he moved down to Washington D.C. to be near his family.

Last October I received a long letter from him, the first since his Parkinson's disease had made it difficult to write. Which is really why I'm writing this. Because this remarkable man, who turned 91 on October 31st, the same day my grandson Peter turned 4, is still remarkable.

He now has someone who works with him helping with his writing, a 33 year old volunteer, Robert Jenkins, whose interests mirror his: AARP, Senior Analyst; Consumer Team; Public Policy Institute. They have been touring Washington, going

to movies, plays, and concerts together.

In October, THE GEORGETOWN LETTER, a quarterly of the retirement residence printed a column on him called: "Resident Spotlight/Charles Cogen/Teachers' Organizer," with major emphasis on his work with the AFT. It was the first time a union piece had been published in the publication. He has had much positive feedback from it.

Mr. Cogen still reads the New York Times from cover to cover, and assists the leader of The Georgetown's current events discussions. He says, "Needless to say, I am not very heartened about the course of public events, and I find especially disappointing, though not surprising, the demise of meaningful national health care reform. "In contrast, he finds the news from UFT and AFT publications, much more optimistic.

Charles Cogen, teacher activist and blazer of new trails, certainly proves the axiom that life doesn't stop at retirement. We should all take a lesson from the entirety of his life. With the help of his friend he's making things happen for him, and

living life to its fullest. And again, he makes me proud!

HEALTH REFORM: 1995 STYLE a.s.a.p., Families USA



Unwilling to support comprehensive health care reform to bring down all health care costs, Republicans are preparing to make deep cuts in Medicare and Medicaid.

Sen. Bob Packwood (R-OR), chair of the Finance Committee, has said that the two programs would have to be cut by \$250 billion over 5 years, and another \$150 billion in the two following years, to balance the federal budget.

The Republicans say these cuts will be painless, that they aren't even cuts, just reductions in future increases in spending. But, if funding doesn't keep up with inflation, it's a cut!

AARP points out that the proposed Medicare cuts would be 3 times larger than any cuts made in the program in previous budget bills. They would cost beneficiaries an average of \$575 a year, probably in the form of higher co-payments and deductibles, or increased premiums.

who those To care as managed Families panacea, the USA report points out that, even under the best of circumstances, it could only realize savings of \$25 billion- one third of the needed. total savings There are fears that some managed care plans may put cost-cutting concerns ahead of patient care.

Added note: Many insurance companies, it turns out, are denying coverage to women who are victims of domestic violence. Last year, Congress found that half of the largest insurers would deny coverage to a woman who had a history of being battered.

One small part of the Contract, passed by the House as part of welfare "reform," reduces eligibility for SSI, a 20 year old program that guarantees a minimal level of income for the aged, blind and disabled. Qualifying for Medicaid and food stamps is often tied to SSI eligibility.

#### TRAGIC UPDATE

On February 14th, two of our active staff members, Christian and Joan Thorpe were the victims of a car accident on the way home from school. Joan, an English teacher at East Middle School, was killed, and Chris, a Guidance Counselor at Ross High School, seriously injured. After a Rehabilitation Program, he is now home. Both had attended the Ready Or Not class this past Fall, and were planning for their future retirement. A Memorial Service is planned for Joan in April. Our thoughts are with Chris as he mends, and deals with his profound loss.
