

## STATE OF THE UNION

At the March general meeting, BTA President, Joe Hogan, addressed ROBS members on the current state of affairs in the Brentwood Schools. Student population and teaching staff have grown. Over 250 of the current staff weren't even born when

we last walked a picket line for contract negotiations!

Classroom space is at a minimum. Separate classes are housed in one room, a bathroom serves as a classroom. Special Ed classes are suffering from changes in State mandates. Most of these classes, with no need for a waiver, are now at 18 students; age categories have been expanded up to a two year range. Resource Room teachers now meet with 30 students a day. Cutbacks in state funding have severely impacted on programs: Early Intervention alone has been cut 20%.

SIT Teams (Site Based Management) are meeting in all schools to make long range plans for improving schools and student performance, but many of the teachers on these SIT Teams do not understand the concepts of setting precedents or

undermining contractual agreements.

Staff and administrators have ongoing meetings to resolve local school problems. The era of the dominating administrator is disappearing, and there is a greater spirit

of cooperation.

BTA, with Joe, Maddie Dwyer (now retired), and Jerry Brophy as negotiators, is presently working on a new contract to take effect July 1, 1996. Their position is that health benefits will not change for present retirees. In the last contract agreement, language was added stipulating that the District would continue to fund retiree benefits at 100%.

However, there are two Long Island court cases that are challenging the PERB Cohoes decision. The outcome of these cases could have an effect on our benefits. Brentwood clerical's represented by a strong professional leadership, are equally

bound by BTA contract negotiations and benefits.

May 21st is School Budget Day all across Long Island. Absentee ballots have been mandated. There are two Board seats on the ballot in Brentwood, and a strong anti-teacher, anti-education climate is prevalent. Tenure is under attack. Guidance counselors are viewed as unnecessary, as are elementary art, music, and physical education programs.

Several ROBS members at the meeting reiterated to Hogan that we are here ready to assist in every way we can. We still care about the Brentwood community. In fact,

many of our members are still Brentwood residents.

At the close of the meeting, ROBS president Dorothy Zuckerman suggested we plan to make this State of the Union address an annual event. The idea met with exuberant approval!

## MEDICARE RHETORIC?

Many folks are getting tired of the rhetoric on Medicare/Medicaid cuts. It is difficult to keep up with the changing directions, the back tracking, the about faces, and everything else that occurs in Washington and Albany these days.

NYSUT's Retiree Office devoted an article in February's The Retiree Organizer to what the real concerns must be for those of us who are retired.

" I do not think it is, 'for greed and not for the good of the community,' to advocate for the maintenance of programs which are so important to seniors on fixed incomes: Medicare, Medicaid, Social Security, etc.. Seniors are part of the community. We have spent our working careers paying taxes....

"As more recent retirees, you and I have a pretty good pension (for now). However, in this office we also deal whose with thousands of retirees pensions less than \$8000 are (...18,000), many of whom are single, do not receive Social Security and are living on a total income below \$8000 per year. ... Some of our oldest retirees are already making choices between meals and prescriptive medicine ....

Mary L.S. Clyne wrote an article in 1993 for the Utica Observer-Dispatch which zeroed in specifically on those teacher's in most need:

"The issue is a delicate one, involving conditions some call genteel poverty, but which amount, others say, to gross and unfair privation. Those whose welfare is chiefly at issue are about 5000, mostly women, ages 80 to more than 100, whose pensions were fixed decades ago at tiny sums. Many didn't come under Social Security protection when they were teaching and couldn't afford to buy in later. Some have no health coverage at all; others have limited assistance.

"'Retired teachers older than 80 are leading lives of quiet desperation in dignified destitution,' said one retiree. Many are unmarried; married women

weren't allowed to teach when these women were young, so they have no husbands' pensions to fall back on and no children to support them in their old age. ...even those who own their own homes are unable to keep them up....

"Others live in apartments, frequently in declining and increasingly dangerous neighborhoods. Most had to find their own way in the world and entered teaching because it was one of the few opportunities open then to respectable young women. Starting out with little, they ended up with less...."

Not only women over 80 are struggling. According to the Retiree Office files, more recent retirees are as well. For example: Retiree A retired 14 years ago on a pension of about \$10,000. Five years ago his district reduced retiree medical insurance. In that one year, A's medical insurance cost increased by \$1000, 10% of his pension. A has had bypass surgery and has diabetes; prescription drug and

So, if the political rhetoric gets to you, think about the above to keep yourself focused. We could all be in the same boat in the not so distant future.

other medical costs are crushing.



## BAG OF TRICKS MEETING




Tuesday, April 2nd's ROBS general meeting promises to be an interesting one. The History Committee will present a video of interviews with ROBS members.

Unfortunately we can't have refreshments due to Library policy, but the meeting will be lively. And there is all that updated legislative information.




## NYSTRS CANDIDATES CHOSEN
