Checks made payable to Suburban Children, Inc., are tax deductible, and may be mailed to Frank Spencer, 3 Nottingham Drive, Wheatley Heights, N.Y. 11798. As Diane Gustaw, coordinator of Suburban Children wrote: "These acts of kindness and unselfish giving models to our clients that there are people who care about them in a system that is not always easy to navigate and sometimes quite frustrating."

Both Ms. Gustaw and Diane Fanning, Education Liaison for Suburban were at the November ROBS meeting to present awards of thanks to retirees Beverly Sheehan, Beverly Fisher, Ivy Rosenthal and Frank Spencer for their work with homeless

children last year.

This year the tutoring work continues with retirees Irene Brown and Verne Spencer at Hemlock Pines Elementary; Frank Spencer and Estelle Hoyt at Southwest; and Mary Ruffino and Ruth McCalla at Northeast. More volunteers are needed both at Brentwood schools, and at Suburban after school programs or Thursdays at 10-12. Contact Frank Spencer, chair of the Committee at 253-0355 if you are able to give some time to help homeless kids learn. It's a rewarding experience for both tutor and tutored.

STAR PROGRAM

The STAR Program (School Tax Relief) was passed by the NYS Legislature earlier this year. The tax cut allows seniors, 65 or older, with incomes below \$60,000, to receive a tax break on their school taxes effective September 1998. A total of \$50,000 will be reduced from the assessed value over a four year period ending in 2001.

All other N.Y. property taxpayers will receive similar school tax relief in the

fall of 1999.

Seniors must submit an application form RP-425 plus proof of income

(federal or state tax return), as well as proof of age. It must be submitted to your local town assessor no later than March 1, 1998 in Suffolk County, and December 31, 1998 in Nassau County.

The STAR Program in no way interferes with any local property tax exemption you may already be receiving.

You should all have received health contracts from the Brentwood District, and signed and returned them by now.

NYSUT is celebrating its 25th anniversary this year. This is a time to look forward - to prepare for the challenges of the future, to set direction for the years to come. Although we are no longer on the firing line, we must continue what we began. We must give our support and experience to those who need us now even as we did in the past. Take an active role - contact your legislators, speak up in your community, attend the board meetings, write letters to support our teaching heirs, become involved with ROBS. You are needed now as much as you were needed then. Stay

involved and continue to roll the union on!



THE Q TIP

IT'S TIME!



No one knows if this year will be a "bad" flu season or not, but it is something we should be prepared for.

We know that the flu can make you feel like last night's pasta, but the real problem is the complications it can cause such as pneumonia. It can be a killer!

Influenza causes about 20,000 deaths in the U.S. each year and results in thousands more hospitalizations.

Older people, those with chronic diseases (diabetes, heart disease asthma, etc.) are most at risk and should be getting shots every year.

Flu season generally lasts from November until spring. Antibodies take about two weeks to develop after your shot.

You say you got your shot last year? Fine - but viruses mutate to elude your immune system and what worked last year might not be helpful this year.

There are three types of flu viruses: A, B, and C. The C type is fairly mild and not

associated with dangerous outbreaks. A and B are another story!

According to the Center for Disease Control (CDC) there are currently two A viruses and one B known to be in circulation. This year's vaccine contains both Type A strains as well as B/Beijing-like strains.

Getting the flu shot cannot give you the flu. The vaccine is made from killed viruses. Some people will get a sore arm, a few will get a fever which can be treated. Because the vaccine is grown in eggs, anyone with an allergy to eggs should consult their doctor.

That's the good news! The bad news is that getting a shot is not a guarantee you won't get the flu. This is because the vaccine strains have to be chosen about 9 months before the flu season and mutation is always a possibility. Mutations reduce the vaccine's effectiveness. Also, the immune system may not be as active in producing antibodies. Even if you do get the flu despite vaccination, complications or hospitalizations are much lower.

If you are 65 or older, or have a chronic disease, it is advisable to discuss pneumococcal vaccine with your physician. This shot, in most cases, will give lifetime

Both vaccines are covered by Medicare.

FLU SYMPTOMS



High fever (3-4 days) Headache General aches and pains Fatigue (usually long duration) Chest discomfort and/or cough

COLD

Usually no fever Runny nose Sore throat (may be present in flu)

In any event, it is best to consult your physician! STAY HEALTHY!!
