SIXTY FIVE YEARS AND STILL WAITING

I have just finished reading the second volume of Eleanor Roosevelt, the biography by Blanche Wiesen Cook. I believe Eleanor Roosevelt was the most influential woman of this century. She has always been my mentor. It came as an overwhelming surprise to learn that universal health care has been a sidestepped issue all the way back to the new deal! When FDR introduced his social security program in January 1935, he included government assistance in all areas except health insurance. The American Medical Association had strongly opposed the introduction of health care into the social security act. The fear was over "socialized medicine." In spite of E.R's persistent lobbying for a national health care program, FDR put off any further discussion on the subject during his tenure. So here we are almost 65 years later, still fighting the same fight and still listening to the same arguments against universal health care for all our citizens. Today the insurance companies have joined the fray. The primary question our country has refused to face is whether the role of government is to provide for the needs and care of the many or for the profits of the few. Throughout the world, universal health care has become a hallmark of social legislation. We have just visited Scandinavian countries that have a proud and long-standing history of providing universal health care while their citizens willingly pay the necessary taxes to protect their well-being. Enlightened governments have recognized the overwhelming need to maintain a healthy, informed populace, capable of providing for their families while making their contribution to the economy without fear of destitution caused by illness. As we close this century we must assume the responsibility for making our voices heard. Universal health care in America is no longer a matter to be put aside for another day. Eleanor Roosevelt is no longer here to speak for our cause. It's up to each one of us to pick up the mantle she so bravely carried and to wear it as our own. If we don't do it, who will?

PATIENTS BILL OF RIGHTS

The AFT is calling for the help of all members to contact their members of both houses in congress supporting the Dingell-Norwood Bill which passed the House by a surprising 275-151 vote in October.

This bill includes whistleblower protection to forbid retaliation against health care professionals who report inferior care – a top priority of the AFT. The bill also removes the special immunity from lawsuits for HMO's.

The bill now goes to a conference committee and must overcome the weak bill passed by the Senate last summer which omits whistleblower protection and maintains HMO lawsuit immunity.

I removed the visor on my motorcycle helmet in order to drive along the "Avenue of the Giants" on the way to Redwood National Park. I needed to look up, way up, and the visor would not let me see the tops of the trees that were over 300 feet tall.

There are many places to see the redwoods in Northern California. They're all over the northern coast but one does not get tired of them. John Steinbeck once said: "The redwoods, once seen, leave a mark or create a vision that stays with you always...from them comes silence and awe. The most irreverent of men, in the presence of redwoods,

goes under a spell of wonder and respect."

Indeed, driving on a road bordered with these huge trees is like entering a cathedral. They block out the sky and it grows dark. They smother sound and it becomes quiet. There is a damp freshness in the air.

Redwood National Park is combined with several California State Parks to preserve the redwoods, protecting them especially from the lumber industry. Harvesting redwoods is big business. The attitude of many residents is captured in the name of a local high school marching band, "The Fighting Lumberjacks."

The parks are necessary to save the redwoods from those who call conservationists "tree-huggers."

Seems to me ROBS is way ahead of the game. We've been doing exit interviews for five years!



BLACK CAUCUS HEARS FROM AFT ON TITLE I

The AFT continues to make the case for reauthorization of the federal Title I program based on sensible reforms instituted five years ago.

Addressing the Congressional Black Caucus annual legislative conference, AFT's political & legislative mobilization department director Juanita Dunlop Smith called for staying the course on the standards-based Title I program put in place during the 1994 reauthorization. "The law's basic framework – implementing high standards in the core academic subjects – is the right one," she said. Title I funding, she

pointed out, has helped to close the achievement gap between economically disadvantaged and advantaged children.

Smith also urged continued support "for the important role of paraprofessionals in Title I programs." Responding to concerns that too many paras are actually teaching students, Smith said the answer is to close loopholes in the law that allow districts to use paras inappropriately and fail to provide them with the necessary training. "When properly trained, supervised and assigned, paras are effective." From ATLACTION, 10/8/99
