RETIREES GEARING UP



Sandra president AFT Feldman told an overflow crowd at December's AFT Retirement Leadership Conference in Washington, D.C., that the coming election is "one of the most important we have ever faced." For the past six years, she said, President Clinton has stopped a great deal of damaging legislation coming from the conservative leaders of Congress. "We cannot lose the presidency," she said. "We a society where want children get nourished, where the elderly have dignity, where the ill get taken care of."

Rep. Steny Hoyer (D-Md.)

told the retirees. "There is no group in America whose energy and faith and devotion lights more sparks or raises higher the torch of freedom than teachers." He asked the retirees to "Teach America about its future" election during the Conference campaign. organizers had expected only 50 to 75 retiree leaders to attend but more than 160 came, (including Dot & Jack Zuckerman) reflecting the growing activity of retiree chapters.

In addition to discussing the political campaigns, conferees focused on the nuts and bolts of building retiree chapters.

AN EARTHWATCHER REFLECTS DONNA MARIE RAGONESE



The Earthwatch Institute involves some 4,000 members in scientific field research with 200 scientists in 48 countries. I was accepted to join Kenya's

WILD HERITAGE expedition last October. With 14 volunteers from 7 states and 5 countries. I stayed at Elsamere, author (Born Free) Joy Adamson's home. Which is on Kenya's largest lake, Naivasha.

It is heavily used by people and animals, and to protect its unique ecosystem, scientists & volunteers have been monitoring it for the past 12 years. As a result Naivasha was declared a Ramsar (a wetland of international importance), local farmers have agreed to maintain a voluntary buffer strip at the lake's edge, and Kenya's Wildlife Services can base conservation measures on the data.

The compound, situated on the lake, consists of 100 acres of acacia woodlands filled with over 350 bird species. The first day we climbed Hippo Point across the lake, a very strenuous climb, 6500 feet above sea level. But the zebra, and giraffe were worth it.

Both Vervet and black & white Colobus monkeys were seen daily around Elsamere. They were fun to watch, and often woke us up early by jumping on the tin roof. After sunset, the 16 lake hippos came up to graze on the lawns 10 to 15 feet from the porch.

For 14 days we worked in the field. I spent time in a small boat on the lake measuring water temperature, turbidity, and collecting water samples around the gorgeous papyrus and water hyacinths. I spent afternoons in the lab measuring, weighing, and counting the zoo plankton that we got from the samples.

We also set traps in Hell's Gate National Park to catch small mammals. We weighed, measured, sexed, took blood samples and then released them. Off in the near distance we could see zebra, giraffe, hyrax, wart hogs, eland, and fish eagles. This is the real reason I love Africa - the animals.

I learned 3 different machines in the lab and tested for phosphates from soil samples from different parts of the shore. I also learned a good deal about the culture from the native Kenyan scientist I was assigned to. I also got to use the laboratory at the local geothermal plant which had more sophisticated machinery.

Four of us climbed Mt. Longonot. I didn't make it to the crater's edge (8500 feet). Instead, I sketched the Rift Valley, and watched the flight of many beautiful eagle.!

We also took an hour flight in a small plane to Masi Mara for a private full day safari. We ate breakfast and lunch sitting on rocks by the Mara River watching hippos play, and stork and vultures swim and attack the carcass of a dead wildebeest. Also lions, elephants, zebras, giraffes, monkeys eating, sleeping, nursing, playing mating, and just plain "hangin' out." Totally fulfilling for me.

My memories will last a lifetime. My friendships will be nourished by mail and e-mail, and perhaps a visit or two. Plus. Africa still beckons - I am already dreaming of a return adventure next year!!

ON THE ROAD AGAIN BY RICH EDWARDS, TOURING THE U.S. BY RV/MOTORCYCLE

1/31/00: Won over \$100 on quinellas at Tampa Bay Downs, the local thoroughbred race track (picked the 1st & 2nd finishers)...

Decided to have a special dinner at Bern's Steak House in an area of Tampa that has seen better days. It is one of the finest eating places I have ever visited. Consider:

- Four 1200 gallon tanks hold fish kept alive until ordered
- Waiters are trained for 1 year
- Most vegetables organically grown on their own farm

- Bread baked from flour they grind in pans made in their own metal
- Steaks are U.S. Prime aged 5 -8 weeks. My filet mignon was the best I have ever eaten
- Wine list is a book of 7000 wines. 23 kinds of caviar, 100 brands of beer

Guests are welcome to tour the kitchen & wine cellar. They are huge!

Dessert is served in 44 private booths, some small and cozy for 2, others large enough for a dozen diners. Each has a control panel to select the type of music one wishes. All 65 dessert selections are made on the premises. They were delicious, but the coffee was spectacular. Each bean is selected for perfection and ground in separate grinders so there is no unexpected blending.

The meal cost \$100 for two but was equal to any the finest N.Y. city restaurants could serve. And it would cost three times as much in the "Big Apple." If you ever get to Tampa, you must visit Bern's.

MUCKETY MUCK THREAT

Robert Reno had some wise words in his 12/8/99 "Reno At Large" column in Newsday. "If you're desperately worried Congress has dithered for another session without "saving" Social Security, relax. Just consider that we got through another year without mucking up a perfectly good system that may not need saving."

He quotes from a new study: "Social Security: The Phony Crisis" by economists Dean Baker & Mark Weisbrot, who take issue with Clinton's 'fix the roof while the sun is shining' statement. "Most who say that want to knock holes in it..." According to the study, "There will be 2.1 workers to support each retiree in 2030. Now

there are 3.3. In 1955 there were 8.6 workers per retiree, and the decline from 8.6 to 3.3 did not precipitate any economic disaster." If the promises of technology mean anything, we should be able to carry this off without throwing away or diminishing a system that enjoys wider support than any other federal program.


