

Public pension reform eases planning...from AFT

Flexibility and portability are the cornerstone of public pension reform language that was signed into law June 7, 2001, by President George W. Bush. The AFT has lobbied for years for changes to the pension laws governing section 457, or deferred compensation, plans. Under the new law, public employees enrolled in section 457 can roll their pensions into individual retirement accounts when they leave or retire from public service or use the fund for purchase of service credits in their defined-benefit retirement system.

By moving money into an IRA, from which money can be withdrawn on the basis of need, pensioners can avoid section 457 rules requiring an irrevocable election of benefits at the time they leave or retire from public service.

These new pension changes were part of the \$1.35 trillion tax-cut measure.

While the AFT strongly disagrees with the massive tax system overhaul because it will undercut federal and state revenues that fund vital government programs, the union has long maintained that public pension laws needed revision to give pensioners greater

flexibility and portability to plan for their retirement. (Find out when you will get your tax refund, if you do: www.GOP. govtaxrelief).

The Washington Post reported that Treasury Secretary Paul O'Neill, speaking to a group of financial executives at a June 18th Luncheon organized by the Coalition for American Financial Security, which supports partial privatization of Social Security, said, "I come to you as managing trustee of Social Security. Today we have no assets in the trust fund. We have promises of the good faith and credit of the U.S. government that benefits will flow." The Post points out that O'Neill signs trustees' reports that the fund contains real assets – the most recent listing nearly \$900 billion in Treasury securities.

News From Around the Quad: NYSUT Organizer

- NYSUT's first Regional Conference on Consumer Fraud was held in May in cooperation with the Office of the New York State Attorney General Eliot Spitzer. It took place in Syracuse and organized by NYSUT Retiree Services Consultant Bonnie Pierce. Recognizing that senior citizens are favored targets of con artists, NYSUT and the Attorney General's Office will offer a series of regional conferences for NYSUT retirees throughout the state.
- Health Insurance Moratorium prohibiting the unilateral diminution of health insurance benefits has been signed into law.
- A bill guaranteeing a minimum pension has been introduced in both the NYS Senate and Assembly. This proposed legislation would raise the current minimum pension from \$350 to \$500 per year of service, up to a maximum of 35 years or \$17,500.
- ◆ TEACH-2 (Senate Bill 5) is currently on the Senate Cal-

endar. This legislation, or the "Teachers Enrichment-2 (TEACH-2) program, is designed to provide school districts new mechanisms to retain senior teachers, as well as attract new and retired teachers into the classroom. Furthermore, TEACH-2 provides financial incentives to teachers who pursue and obtain national certification and to reward those teachers designated as the "State Teacher of the Year." TEACH-2 also waives certain fees associated with taking the exams required to become a certified teacher. It is hoped that these new programs will help to attract both new and retired teachers into the classroom in an effort to mitigate the potentially catastrophic impact of the impending teacher shortage on our public school students as these students work to achieve higher academic standards. (Ed. Comment: Ever notice that they always close the barn door after the horses have escaped??)

"What if Baby Boomers Can't Retire?" by Thornton Parker

Thornton Parker is a financial and management expert for government and industry, and argues that the wealth we think we are accumulating (in IRA's and other tax-deferred plans) may be an illusion.

His book, What if Baby Boomers Can't Retire? is a powerful message for the nearly 40 million Americans who have put trillions of dollars and their hopes for retirement in savings plans and on the stock market. He calls it "phantom wealth," which he defines as "something that appears to be but has no real or physical existence...the returns from corporate stocks that are based on market prices" which often have little relation to real wealth and value. "Using stock prices to measure wealth is like counting the chickens before they are hatched."

The recent "dot-com" stock bubble was a recent lesson in phantom wealth. The lure of this wealth has driven old-line businesses to boost stock prices – temporarily– without adding to the company's real value. Those with IRA's and 401(k) plans have been jolted by the sharp declines in the (paper) value of their holdings, which gives them doubts about the financial security of their later years.

The Economic Policy Institute says that declines in the stock market tend to occur every generation, and can take decades to recoup; time those nearing retirement do not have. EPI feels that the Bush plan to convert a portion of Social Security funds into millions of 401(k) plans is a dangerous policy proposal.

And Parker says that even if the stock market goes up, as it certainly would, from the infusion of all that (401k) cash, the increase would be "phantom wealth." He adds that "few stocks pay significant dividends, so the only reason to buy them for retirement plans is appreciation – the expected increase in the price of shares. But until a stock is sold, any increase in its price is just a paper gain, and paper gains don't buy groceries."

He adds, "Baby-boomers' retirement plans have created a national stocks-for-retirement cycle, in which workers buy shares that they will sell later for retirement income." And while "promoters and managers of stock-based retirement accounts...have shown how easy it is to buy lots of stuff, they haven't offered anything like a good explanation of whom they will sell all the stuff to in the future...."

According to Saul Friedman in his NEWSDAY column, "Gray Matters," "This is the 20th anniversary of the 401(k) and such plans have yet to prove their worth for retirement. But those of us in retirement, who have such plans, (along with pensions), are in the vanguard of the problem boomers will face: How and when should we convert that phantom wealth to grocery money when we need it?"

Here's hoping the baby-boomers read this book, and don't cash in all their "phantom wealth" at the same time!

Easy Steps to Finding a Used Car

Since most new cars today can be very expensive, many consumers shop for used cars as allordable alternatives. If you've decided to search for a good deal on a used car, the first thing you want to do is not yournelf some base questions.

 How will you use the webscle (e.g. recreation, work, etc.)*

· How long do you plan to keep it

. What is your budget for the purchase. (This should include insurance and municipance costs.)

- New car dealers acquire most of their used cars through trade-ins when people purchase new cars.
 You can often get a warranty, too.
- Used car dealers generally deal with care that have a little more "wear and tear" than those sold at new car dealers. Check the dealer's reputation and reliability first. Some used car dealers may offer innited warrantes.
- Car rental agencies often sell used rental cars.
 The company can usually provide the car's maintenance and repair records and possibly ofter a limited warrante.
- Bank and loan companies sometimes sell cars to pay off defaulted loans. Since the whicle is being sold to recover the amount due on a loan, it may be possible to get a good deal on a reliable car.
- Private owners usually sell their cars through newspaper and magazine classified ads. Although time-consuming, you may find a well maintained car selling for less money than at a dealership. One of the drawbacks, however, as that the warranties are not available when you go this rouse.
